School Closures:

Our School is closed on the following holidays: New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Friday after Thanksgiving Day, and Christmas Day. If the holiday is on a Saturday, we will be closed on the Friday before for observation of the holiday. If the holiday is on a Sunday, we will be closed on the following Monday to observe the holiday.

Our School closes early at 3:00 p.m. on Christmas Eve and New Year's Eve.
